SECTION I

1. INTRODUCTION

The National Land Commission (NLC) is a constitutional body established by the Constitution of Kenya 2010, National Land Commission Act, 2012, the Land Act 2012 and the Land Registration Act of 2012.

2. OBJECTIVE

The purpose of this Notice is to seek for Expression of Interest from suitable individual consultants or organizations who wish to lead teams in conducting research on the conservation, **management the development of a policy framework on Riparian Land in Kenya**. The consultant researcher should be willing to act as coordinator for the project.

3. SCOPE OF WORKS

Submitting an Expression of Interest (EOI) is the first phase in the project selection process.

The EOI should clearly and concisely explain the research activity's relevance, purpose, objectives, activities and expected results in support of the objectives of the National Land Commission mandate as set forth in the Constitution Article 67 ... *to 'conduct research related to land and the use of natural resources, and make recommendations to appropriate authorities'*.

There are growing concerns over the unsustainable use of the fragile riparian ecological zones. This EOI focuses on the subject of Riparian lands and the policy framework development. After evaluating EOIs, the NLC will contact those who submitted successful EOIs to enter into a second phase by submitting a full proposal based on the concepts and technical approaches proposed in the EOI. All EOIs must not exceed 5 pages and must be submitted in the following format:
